Alderman Violet moved and Alderman Aytes seconded the motion to remove Draft Ordinance Changing November 2016 BOA Regular Meeting Date from the agenda for discussion. The motion was approved.

DRAFT ORDINANCE CHANGING NOVEMBER 2016 BOA REGULAR MEETING DATE –
MAYOR

Mayor Pagano explained that there are several activities that the Board of Aldermen members will be attending which will prevent a quorum to conduct the scheduled meeting on November 17, 2016. Therefore, a draft ordinance for a new meeting date is proposed for November 10, 2016, in lieu of any other Regular Meetings during the month of November 2016. The draft

ordinance is on this evening's Board of Aldermen meeting agenda for consideration. **This is business item I-03 on this evening's Board of Aldermen meeting agenda for consideration.**

Alderman Hollingsworth moved and Alderman Reitmeyer seconded the motion to remove Draft Resolution to Write-off Delinquent Personal Property Taxes from the agenda for discussion. The motion was approved.

DRAFT RESOLUTION TO WRITE-OFF DELINQUENT PERSONAL PROPERTY TAXES – CHARNISKY

Mr. Charnisky explained that a Resolution is needed to write-off the Personal Property taxes that are over 5 years old and a draft Resolution will be presented at the next Board of Aldermen meeting for consideration. The annual Collector's Report for 2010 taxes has been provided in the packet; which shows a total unpaid amount of \$7,337. Alderman Hollingsworth moved and Alderman Aytes seconded the motion to place this item on the February 25, 2016 Board of Aldermen meeting agenda. The motion was approved. **This item will be placed on the February 25, 2016 Board of Aldermen meeting agenda for consideration.**

Alderman Barclay moved and Alderman Hollingsworth seconded the motion to remove STP-Urban Program Agreement for McClay Road Improvements Project from the agenda for discussion. The motion was approved.

STP-URBAN PROGRAM AGREEMENT FOR MCCLAY ROAD IMPROVEMENTS PROJECT – BATZEL

Mr. Batzel explained that the City has received a grant for road resurfacing and provided an aerial view of the project area on McClay Road that will expand from Shepherd's Hill Drive to Jungermann Road. This project will include traffic signal improvements at Thoele and Jungermann Roads, diamond grinding, and ADA and sidewalk improvements. This project is estimated to cost approximately \$1.2 million with 80% (\$985,992) covered by this MODOT grant with an estimated completion date of 2017. Discussion was held regarding the vertical curve in the roadway; and if there is any accident comparison studies completed comparing when McClay and Thoele was a three-way stop against the current light signal. Mr. Batzel clarified this is only a resurfacing project; and he advised he can look into the three-way stop against current light signal. Alderman Hollingsworth moved and Alderman Aytes seconded the motion to place this item on the February 25, 2016 Board of Aldermen meeting agenda. The motion was approved. **This item will be placed on the February 25, 2016 Board of Aldermen meeting agenda for consideration.**

Alderman Hollingsworth moved and Alderman Bateman seconded the motion to remove Amendment to Engineering Agreement for Jungermann Road Bridge Replacement from the agenda for discussion. The motion was approved.

AMENDMENT TO ENGINEERING AGREEMENT FOR JUNGERMANN ROAD BRIDGE REPLACEMENT – BATZEL

Mr. Batzel showed an aerial view of the Jungermann Road Bridge replacement project area and explained the project, which is under design. The design consultant, HR Green, has complete about 60% of the design and determined that additional work is needed to be done. This request is for an amendment to HR Green's professional services agreement for some additional engineering to include the design of a retaining wall on the west side of Jungermann Road from the creek to Barkwood Trails, storm water drainage improvements and a traffic signal modification. This work would help eliminate flooding on the roadway and the amendment would increase the original contract by \$31,179 to bring this project to final design. Questions from the Aldermen were addressed. Alderman Reitmeyer moved and Alderman Bateman seconded the motion to place this item on the February 25, 2016 Board of Aldermen meeting agenda. The motion was approved. **This item will be placed on the February 25, 2016 Board of Aldermen meeting agenda for consideration.**

Alderman Barclay moved and Alderman Hollingsworth seconded the motion to remove Bid Recommendation/ Premier 370 Sanitary Pump Station 7 from the agenda for discussion. The motion was approved.

BID RECOMMENDATION/ PREMIER 370 SANITARY PUMP STATION 7 - MALACH

Mr. Malach explained the bid recommendation to construct the sanitary pump station number seven. The City received seven (7) bids and staff recommends the low bid of Kolb Grading, LLC at a cost of \$559,352. Kolb also constructed the other four existing sanitary pump stations in the Premiere 370 Business Park. Alderman Violet moved and Alderman Hollingsworth seconded the motion to place this item on the February 25, 2016 Board of Aldermen meeting agenda. The motion was approved. **This item will be placed on the February 25, 2016 Board of Aldermen meeting agenda for consideration.**

Alderman Bateman moved and Alderman Reitmeyer seconded the motion to remove Secretary of State/Records Retention Schedule from the agenda for discussion. The motion was approved.

SECRETARY OF STATE/RECORDS RETENTION SCHEDULE - SMITH

City Clerk Smith stated that the Destruction of Records forms provided in this evening's meeting packet necessitate being entered and made a part of the minutes of the Board of Aldermen for February 11, 2016. MISCELLANEOUS UPDATES – CHARNISKY

Mr. Charnisky reminded the Board that Business item I-01 on the agenda is based on the last budget meeting when the Board agreed to proceed with the no tax increase bond issue. This Resolution will help the City reimburse the costs spent in connection with the project.

Mr. Batzel explained that the heavy rains in December caused a section of creek bank to collapse near Laurelwood. The contractor on site for the P-7 contract is working on a cost estimate, which would be approximately \$30,000 to repair. Mr. Batzel requested approval to place this item on the next Work Session and Board of Aldermen meeting agenda. Alderman Barclay moved and Alderman Hollingsworth seconded the motion to place this item on the February 25, 2016 Work Session and Board of Aldermen meeting agenda for consideration. The motion was approved. **This item will be placed on the February 25, 2016 Board of Aldermen meeting agenda for consideration.**
