



# Recycle City Tipping Structure

## **VOLUME RATE QUALIFICATIONS:**

Certain customers may qualify for a volume rate discount based upon the monthly amount of waste tonnage they tip at Recycle City. The rates are based upon the calendar month. These rates do not apply to waste tipped by the St. Peters Solid Waste Department. The rates are as follows:

Tons Per Month	Compacted Waste*	Bulky Waste*
100	\$33.26	\$36.39
65	\$33.78	\$36.91
45	\$34.30	\$37.43
20	\$39.51	\$42.64

\*Price Billed Per Ton

Note: Customers that qualify for the volume based billing will be billed monthly and charged according to their tonnage qualification. If a customer does not provide the minimum monthly amount of 20 tons they will be charged at a rate of \$60 per ton. A customer that does not meet the minimum tonnage for two months during a calendar year will have their account converted to convenience billing and charged the Gate Rate.

## **COMPLIMENTARY STORAGE OF CONTAINERS:**

As a benefit to our volume billed customers we will allow the storage of empty solid waste containers on site as space permits. A space is defined as a 30' x 15' area.

45	10
20	5

### Conditions of storage

- We do not have any responsibility or liability for the condition of the containers.
- Access to the storage area is limited to normal operating hours of Recycle City.
- Excess storage spaces used will be charged a fee of \$10 per month per slot for volume billed customers and \$20 per month per slot for other customers.



# Recycle City Tipping Structure

## **SUSPENSION/TERMINATION OF BILLING ACCOUNT:**

Any customer that does not pay their previous monthly bill in full by the 15<sup>th</sup> of the following month will have their account suspended. No further charges will be allowed on the account until the account is paid in full. For customers being billed through a volume billing account any trash tipped while the account is suspended will not apply toward monthly total or discount.

## **RATE DEFINITIONS:**

**Gate Rate:** This is the rate at which anyone can tip trash at Recycle City of \$60 per ton. There is a minimum charge of \$45.

**Volume Rates:** This is a series of rates that are available to any customer providing a minimum of 20 tons a month on a consistent basis.

**Volume Billing Account:** This is a billing account set up at Recycle City to permit certain customers a discount based upon volume of trash tipped. To qualify, a customer must tip at least 20 tons per month on a consistent basis. Only the tons billed to the account will count toward the monthly total. In other words, if tonnage is tipped when account is suspended, that tonnage will not apply toward monthly total or discount. A monthly charge limit will be established for each account.

**Convenience Billing Account:** Customers that do not provide enough monthly volume to qualify for the volume billing account may apply for a convenience billing account that is secured by a credit or debit card. A monthly charge limit will be established for each account and billed on a weekly basis.

**Account Suspension/Termination:** Any account which is not paid in full by due date will be suspended and further charges to the account will not be accepted until the account is paid in full unless specifically authorized by the Group Manager of Health & Environmental Services.
