



# Block Party Permit St. Peters Police Department

**APPLICATION MUST BE RECEIVED TWO WEEKS PRIOR TO EVENT**



- Upon approval, a copy will be mailed to the Applicant that must be kept on site during the Block Party event. Applicant will be contacted by phone if the permit is denied.
- Only moveable barricades may be used to block portions of the street (i.e. trash cans, cones, sawhorses) to allow emergency vehicles accessibility. Cars may not be used as barricades.
- Applicant must notify affected neighbors in writing of proposed event for possible objection two weeks prior to event.
- Applicant must adhere to any additional licensing and permits if required by the City of St. Peters.
